Records: Dealers and exhibitors.

The facility's disposition records are incomplete. The written inventory for parakeets is listed at 198. There are 185 birds present in the facility during inspection. The facility has not been recording when birds are transported, sold, euthanized, or otherwise disposed of by the exhibitor.

Appropriate documentation of regulated animals is essential for proper identification, to trace and track animals in case of disease outbreak, and to ensure all parties that are required to be licensed have a current, valid license.

Every exhibitor shall make, keep, and maintain records or forms which fully and correctly disclose the following information concerning animals, other than dogs and cats, purchased or otherwise acquired, owned, held, leased, or otherwise in his or her possession or under his or her control, or which is transported, sold, euthanized, or otherwise disposed of by that dealer or exhibitor. The records shall include any offspring of any animal while in his or her possession or under his or her control.

Housing facilities, general.

The door to the exhibit holding four ring-tail lemurs has not been replaced when worn. The majority of the door's wooden bottom rail is scratched, exposing untreated wood. Failure to maintain surfaces of housing facilities hinders the ability to adequately clean and sanitize and may affect the health and well-being of the animals. All surfaces must be maintained on a regular basis. Surfaces of housing facilities that cannot be readily cleaned and sanitized must be replaced when worn or soiled.

Inspection Report

Trash cans in the housing facilities are not leakproof and do not have tightly fitted lids. Approximately eight trash cans containing refuse from the lemur and squirrel monkey exhibits, among other species, are present at the rear of the housing room. The trash cans lids have a circular hole cut in the top of the lid to allow for storage when not in use. Thus, the trash cans are not leakproof and do not minimize vermin and pest hazards. The facility must ensure that trash containers in housing facilities and in food storage and food preparation areas are leakproof and have tightly fitted lids on them at all times.

Correct by September 11, 2024

This is a 1st Re-License Inspection for a Class C license. The inspection and exit briefing were conducted with the applicant.

All items must be in compliance within 2 more inspections or by November 1, 2024 or the applicant will forfeit the license fee and must wait 6 months to reapply. Please contact your inspector to schedule your next Re-License Inspection.
